

Equestrian Charitable Promotion Terms and Conditions

- This offer is promoted by SEIB Insurance Brokers Limited ("SEIB"). SEIB Insurance Brokers is a trading name of SEIB Insurance Brokers Limited who are authorised and regulated by the Financial Conduct Authority. Registration number: 479477. SEIB's registered office address is at Benefact House, 2000 Pioneer Avenue, Gloucester Business Park, Brockworth, Gloucester, United Kingdom, GL3 4AW.
- Eligibility: Any customer of SEIB who renews or takes out an Eligible Insurance Policy (defined below) arranged through SEIB which has a policy inception date occurring between the dates of 00:01am on the 3rd July 2023 through to 11:59pm on the 30th September 2023 inclusive (the "Offer Eligibility Period") will be an "Eligible Customer" for the purposes of this offer.
- 3. An Eligible Insurance Policy for the purposes of this promotion means one of the following policies of SEIB horse insurance:
 - a. a SEIB Classic Horse Insurance policy; or
 - b. a SEIB Core Horse Insurance policy
 - but excluding all other SEIB policy types.
- 4.
